 CACFP Updated Policy Guidance and Memoranda



Nutrition Services has released new policy guidance and memoranda for the CACFP. For more information, see below:

- DECAL Policy No. CACFP 17-39: The policy was revised from its previous versions. Revisions include further guidance in the following sections:

The guidance serves as an addendum to the current CACFP and SFSP recordkeeping policies and addresses common problematic areas of program financial recordkeeping among CACFP organizations. Included in this guidance is a Financial Recordkeeping Checklist.

 New Web-Based Interactive Food Buying Guide Now Available!

The Nutrition, Education, Training, and Technical Assistance (NETTA) Division of the Food and Nutrition Services Child Nutrition Program Unit has released the first phase of the new web-based, interactive **Food Buying Guide** (FBG). The features associated with this resource include search and navigation features, comparison features for yield information, and the ability for users to create and save favorite food lists. The tool also incorporates an exciting new feature: the Interactive Product Formulation Statement Workbook. This feature allows manufacturers to easily search and populate selected food items, calculate their product's contribution statement, and generate a document that provides crediting information for CN Program Operators.

#### **GA ATLAS Self-Registration Instructions:**

- 1. Check the account profile within "My Training."
- 2. The training contact information should include the Primary Contact's first and last name, phone number, and email address. (Otherwise the training will not be linked correctly and will cause issues with the training roster.)
- 3. The Updated Meal Patterns Training will be listed under "CACFP Homes, Other."

Note: Due to limited space and need, *only one person* from each institution will be allowed to attend. The Primary Contact (PC) is not required to attend; a staff member responsible for meal planning or preparation can represent the organization and take back information to share. If anyone other than the Primary Contact is registering for this training, contact Leslie Truman at (404) 657-1779, as GA ATLAS will only register the PC.
