Dear DECAL Team,

At the beginning of January 2018, Governor Deal made his annual *State of the State* speech to the Georgia General Assembly, invited guests, and the citizens of Georgia. At the end of January 2018, President Trump made his annual *State of the Union* speech to members of Congress, invited guests, and the American people.

So I decided, "I think it's time to share my perspective on the *State of Early Care and Education in Georgia 2018*" with you, the women and men committed to meeting the early education needs of Georgia's children and their families.

I am proud to say that the state of early care and education (ECE) in Georgia is strong, evolving, responsive, and caring, and following are just a few of the reasons I feel justified in saying so.

1. We have a department of state government that houses almost all the services, programs, and resources relating to child care and early education for children from birth to age five. In most states, these programs/services are spread across multiple agencies making aligning services and communication more difficult...and less effective.
2. We have not only transitioned CAPS from DFCS to DECAL...we are transforming the program to become a component of Georgia's early education system, not just subsidized child care. At DECAL, CAPS is benefiting children, families, child care programs, and communities in new and different ways.
3. We are continuing to administer an established voluntary, universal Pre-K program that is celebrating its 25th birthday this year. The celebration honors the legacy and foresight of

Andrews Receives Servant's Heart Award

Cassa Andrews, manager of the Positive Behavioral Interventions and Supports (PBIS) Program, has been awarded First Lady Sandra Deal's With a Servant's Heart Award for her volunteer work with a religious organization that established and administers several schools in Pakistan. The goals of these schools are to educate Christian and Muslim students together, to educate girls, and to educate children with disabilities. The schools employ Christian and Muslim teachers in an effort to show how teachers of different faiths can work together to educate the children of their country.

In nominating Cassa for the honor, Commissioner Amy M. Jacobs wrote, "Cassa's work on behalf of children and teachers has not only cost her financially, it has come with a cost to her personal safety. On her most recent trip to the country this past summer, a bomb exploded in a market place where Cassa was shopping. Though her injuries were not life-threatening, the recovery from injuries to her legs has been slow and painful."

Through her decade of trips to Pakistan, Cassa has personally funded her travel and living costs and expenses for supplies she has been able to take with her. She also contributes substantially to a school for children with disabilities, including sponsoring several children so they can attend the school.

Previous DECAL recipients of With a Servant's Heart are Laura Wagner, Family Support Director with Georgia's Childcare and Parent Services (CAPS) Program, and Richard Bartlett, Compliance Examiner with DECAL's Audits and Compliance Team.

- Governor Zell Miller and others who came before us backed by research proving that Pre-K has positive outcomes across all domains of learning. And the effectiveness of the Pre-K program has spawned the creation of summer transition programs to better prepare young students for Pre-K and Kindergarten.
4. We are broadening the academic focus of our services to begin reaching children from birth to Pre-K.
 - o Early Language and Literacy Classroom Grants are supporting 50 classrooms across the state in implementing research based language and literacy instruction for children from birth to age three, the earliest, and most critical, years of life.
 - o The Georgia Center for Early Language and Literacy at Georgia College and State University is equipping early education teachers with research-based practices related to early language development and literacy for children from birth to age eight.
 5. With support from the Georgia General Assembly, we now have the Georgia Foundation for Early Care and Learning that will allow corporate and philanthropic partners to provide private funding to support early childhood educators and child care providers in ways that state and federal funding could not.
 6. We have expanded services or developed new services in response to expressed needs from stakeholders, providers, and families:
 - o Trained and supported thousands of early education professionals on inclusion and social and emotional development ensuring that all children are supported and can succeed in high quality early learning programs.
 - o Improved technology to make information even more accessible and user-friendly for parents and providers through website enhancements and social media now reaching over 15,000 followers every day, 24/7.
 - o Fed millions of meals and snacks to more children and eligible adults every year through our federal nutrition programs reaching counties that have not participated in previous years.

Of course the accomplishments I mentioned above are just a few of the reasons I believe the state of ECE in Georgia is as strong as it's ever been. I easily could have listed more...but these items clearly illustrate the significant strides Georgia has made in early care and learning in the past years.

I hope YOU feel the same pride I do when I review the current state of ECE in Georgia. I assure you: We wouldn't be in this solid, stable place...from which we can continue moving forward to enhance the well-being of children, families, and the child care community...if it weren't for you and your commitment to exemplary customer service.

Lewis Named to NARA Board

Kristie Lewis, Assistant Commissioner for Child Care Services, has been named to the Board of Directors for the National Association for Regulatory Administration (NARA), an association dedicated to supporting regulatory professionals throughout North America who ensure the health and safety of individuals in out-of-home care.

"I am honored to serve with NARA, the only national organization that advocates for human care regulation policy," said Lewis. "We spent this past weekend doing strategic planning for NARA through 2020."

Lewis has worked in child care since the early 1990s beginning as a child care preschool teacher and a child care learning center director. She joined state government as a regional licensing consultant with the Georgia Office of School Readiness, the predecessor of DECAL. With DECAL she has served various leadership roles including Applicant Services Unit Director, Licensing Regional Director, and Child Care Services Director. She was appointed Assistant Commissioner for Child Care Services in 2013 responsible for more than 120 child care licensing staff who monitor and support the almost 5,000 child care programs in Georgia.

Lewis also serves DECAL as Co-Administrator for the federal

access to quality learning and to fulfill their full potential. Including children with disabilities in high quality early learning environments is a major focus at DECAL. Jennie Couture, Director of Practice and Support Services, explains: "When we support full participation in high quality early learning, we support all children's full potential."

In 2009, the Division for Early Childhood (DEC), the National Association for the Education of Young Children (NAEYC) and various stakeholders in the field carefully developed a definition of early childhood inclusion that is still used. According to the definition, the results of inclusion are a sense of belonging and membership, positive social relationships and friendships, and development and learning to reach a child's full potential. These results align with the Commissioner's vision for DECAL and with the work we all do to ensure that every child has access to a

high quality early learning environment.

One of child care providers' most common misunderstandings involves what actually makes an early learning setting inclusive. DECAL's Inclusion Specialists work with child care providers to help them better understand how to modify their environments, materials, and activities so all children can actively engage in their environment. This is just one example of how DECAL continuously supports and promotes high quality early learning experiences for all children, including children with disabilities.

We work hard to eliminate barriers to high quality care for children with disabilities. DECAL Inclusion Manager Brandy Locchetta says, "One goal of our work is to help society understand that the only barriers to inclusion are our own mindsets and preconceived ideas of what disability is and what having a disability means." 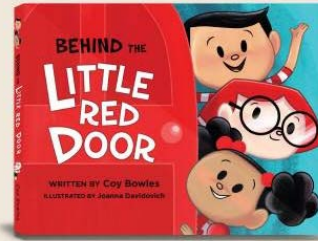

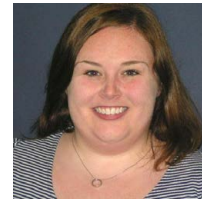

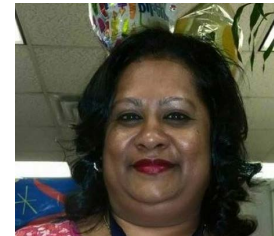
