PROCUREMENT-RELATED POLICY MEMORANDA



A recent policy memo was issued by USDA FNS on January 17, 2018 addressing "Market Basket Analysis when Procuring Program Goods and Modifying Contracted – For Product Lists." The policy memo addresses the ability of program operators in the National School Lunch Program, School Breakfast Program, Summer Food Service Program, and Child and Adult Food Care Program to award contracts based on evaluation of the lowest price using a representative sample of goods. This practice is called "Market Basket Analysis".

The policy memo also addresses modification of contracted products when acquiring additional goods or increasing quantities. When program operators need to increase goods or add additional items to an existing contract, the applicable procurement method must be depending on the value of the items used unless the additional goods will be an ongoing purchase.
