The Chef Ann Foundation is offering \$2,500 grants to schools for Project Produce: Fruit and Veggie Grants for Schools, a program that supports schools in purchasing fresh fruits and vegetables and showcasing them via planned lunchroom activities where students can taste fresh produce and take part in nutrition education.

Any district or independent school participating in the National School Lunch Program (NSLP) is eligible to apply. Applications are accepted on a rolling basi depending on funding.

Thank you for your commitment to ensuring children have healthy, well-balanced meals this summer! GA DECAL is continuing to work with sponsors across the state to facilitate continued expansion and increase SFSP access to children. In conjunction with expansion efforts of the Department of Education, there were 229 sponsors and 3,492 sites across the state of Georgia serving meals and snacks. Sponsors participating in the SFSP are serving meals in 104 counties across the state, an increase of 4% over 2015. Additionally, six of the nine FY 2016 targeted counties have at least one summer meals site. Preliminary data shows a slight increase in meals served in May and June with over 2.8 million meals served. Your commitment to your local communities ensures that children who did not have access to meals at all in their county last year, do have access to nutritious meals this year. Preliminary meal data indicates a likely increase in SFSP meals and snacks served year-over-year. Thank you for your hard work and tireless efforts to expand summer meals across the state of Georgia.

As summer begins to wind down, we encourage you to consider participating in the CACFP At-Risk Afterschool Program. As a sponsor of this program, your organization will be able to provide a free afternoon snack and supper meal to children in concert with approved afterschool programming at the licensed childcare or after-school facilities. An upcoming SFSP to CACFP Transition Info Training Session will be held Thursday, September 15th (10:00-11:30am) for all sponsors interested in or considering serving meals year-round.
