The Chef Ann Foundation is offering \$2,500 grants to schools for Project Produce: Fruit and Veggie Grants for Schools, a program that supports schools in purchasing fresh fruits and vegetables and showcasing them via planned lunchroom activities where students can taste fresh produce and take part in nutrition education.

Any district or independent school participating in the National School Lunch Program (NSLP) is eligible to apply. Applications are accepted on a rolling basis depending on funding.

SFSP sponsors interested in serving meals yearround in their communities should consider participating in the At-Risk Afterschool component of the Child and Adult Care Food Program (CACFP). Afterschool programs that provide structured, organized enrichment or educational activities to enrolled participants up to age 18 may be eligible to participate in the At-Risk Afterschool program.

Sponsors interested in learning more about the At-Risk Afterschool program should attend one of the upcoming training sessions on the program. Training topics include an overview of CACFP eligibility requirements, nutrition and menu planning, recordkeeping, and other essential CACFP information related only to afterschool programs.
