This summer we asked you to focus on eliminating as many targeted counties as possible. There were 14 targeted counties this summer that had no access to summer meals through the SFSP or the Department of Education's Seamless Summer Option (SSO) in 2014.

Due to the collective efforts of your hard work as sponsoring organizations and school systems that participated through SSO, targeted counties decreased by 35.7%! Thank you for your efforts and dedication to ensure children across the state had access to healthy and nutritious meals.
