#### Budget Updates



Criteria for Budget Revisions have been updated. For costs already approved, a revision is needed only if there is an increase or decrease by 25% or more.

- Cost categories 1-4 of the budget must be revised if there is a 25% change by category.
- Items 5A-8D must be revised if there is a 25% change by line item.
