Quality Rated Language and Literacy Endorsement Update

DECAL charged by Governor Kemp to develop and offer an "added" endorsement to Quality Rated providers who want to raise literacy standards and practices for children in their care.









Quality Rated Early Language and Literacy Endorsement Update (continued)

- Expert Committee met May, June, and September 2019.
- Recommendations for endorsement drafted and feedback solicited
- Draft recommendations currently being finalized
- Public comment period, stakeholder engagement, and finalizing recommendations conducted by end of 2019
- Implement pilot of endorsement early 2020

Quality Rated Early Language and Literacy Endorsement, *Draft Recommendations*

- 1. Endorsement should support programs in continuous quality improvement.
- 2. Only programs with a 2- or 3- star rating will be eligible to earn endorsement.
- 3. Endorsement process should prioritize programs and communities serving high proportions of children and families from vulnerable and underserved populations.
- 4. DECAL will develop professional learning supports based on available data, past experience, and knowledge of best practices.
- 5. Endorsement should require professional learning based on the individual needs of programs, teachers, and families.
- 6. Endorsement should be awarded after a program successfully completes professional learning and develops a DECAL-approved plan for sustaining practice and professional learning.






A Landmark Year!

The ninth annual Georgia Pre-K Week took place on October 7-11, 2019.

Over the last eight years, 155 of 159 counties (97%) have participated in Pre-K Week. This year, the remaining four counties registered to participate. That means 2019 marks the year, since the inception of Pre-K Week, that we have **100%** county participation!



State Leader Involvement

More than 190 visits to Pre-K centers were made by 134 state leaders including:

- 41% of the Georgia Senate (23 of 56)
- 46% of the Georgia House (81 of 178)
- 50% of new legislators participated this year! (21 of 42)
- First Lady Marty Kemp made 2 visits
- 9 Commissioners & 3 State Agency Reps
- 5 Georgia Congressmen & 4 Congressional Reps
- 9 other state leaders, including:
 - President/CEO of the Georgia Lottery, members of Governor Kemp's staff, members of Lt. Gov. Duncan's staff, as well as leaders from other organizations

Pilot program using **coaching** strategies and **training** for newly licensed programs



Goal of TA Pilot

Provide **positive and proactive support** to new programs and help them create systems to maintain compliance



Since December 2018, **267** programs in **Support** or **Deficient** compliance status were assigned to six CCS TA consultants. Of those programs assigned, **15%** had been licensed less than 12 months.



During the same time period, **122** programs underwent a Change of Ownership, and **12%** of those programs fell out of compliance within 12 months of the new owner operating the program.



Pilot Program Components

- Complete initial needs assessment
- Coaching/TA visits every two weeks
- Explanation of licensing visit expectations
- In-depth review of DECAL KOALA
- In-depth review of enforcement chart and possible adverse actions



Business Practices Training

- Core rules overview for CCLC & FCCLH programs
- Manager series based on McCormick Center training
- Topics include: Leadership Practices, Preventative Practices, Effective Communication, and Staff Morale



- Pilot programs will be tracked for 12-24 months after intensive support has ended to monitor compliance level.
- Newly licensed programs can choose to receive intensive TA and coaching to help them maintain compliance after being licensed.







Quality Rated Validation Study 4th Report -Summary Findings



Center-based programs and FCCLHs with the highest Quality Rated star rating were generally of higher quality than lower-rated programs.



Preschool children in higherrated programs learned more than children in lower-rated programs in some, but not all, domains.



In center-based programs with higher star ratings, the work climate was better in terms of turnover, wages, and employee benefits.






CAPS Provider Types & Children Served


Most children receiving CAPS scholarships are in licensed centers.



Priority Groups Supported by CAPS




CAPS providers are *less likely* to earn 3 stars and *more likely* to earn 1 star compared to non-CAPS providers.



33% of children enrolled in CAPS are receiving care at programs not yet Quality Rated.

- 1,130 CAPS providers do not have a rating.
- 527 of these CAPS providers have 11 or more active CAPS scholarships.
- If this specific group earns a star rating, 92% of children would be in Quality Rated child care.



IMPORTANT ANNOUNCEMENT

In order to continue to receive Childcare and Parent Services (CAPS) funding, eligible providers must be Quality Rated by **December 31, 2020**.

If you have not started the Quality Rated process, please consider doing so now by calling the Quality Rated helpdesk at 855-800-7747 or by visiting QualityRated.decal.ga.gov.

CAPS providers who earn a star rating will receive tiered reimbursement on their CAPS payments. Tiered reimbursement is a quality bonus that increases your total CAPS payment by 10% for one star, 20% for two stars, and 40% for three stars. Families at Quality Rated providers also receive a 15% discount on their family fee.

Please indicate below by selecting an option of your intent to continue to be a CAPS Provider.

Only 4% of unrated CAPS providers responded that they did not intend to become Quality Rated and be a CAPS provider after December 31, 2020.

Unrated CAPS providers were surveyed. 1,015 respondents reported the following:

- 77% plan to earn a star rating.
 - 16% ready to submit portfolio
 - 56% receiving TA and portfolio in progress
 - 14% receiving TA and portfolio not started
 - 14% need more information about becoming Quality Rated
- 19% were unsure.
- 4% plan to opt out.


Providers not yet observed for a rating can no longer participate in CAPS. Scholarships of existing families receiving CAPS will be end dated at the time the family completes their redetermination in 2021.





Transition timeline of families to Quality Rated providers

After May 1, 2020, families may select only QR providers or those signed up for observation If provider not star rated or observed, families move to QR provider at next renewal after January 1, 2021





Communication with Families



Family Communications

- DECAL developing multifaceted, ongoing communication plan.
- General communications about the benefits of choosing a Quality Rated provider have begun.
- Communications to all CAPS families around plans for the 2020 goal and what families can expect will begin in December 2019.
- Communications to all CAPS families will also occur before each major milestone.
- Targeted communications with families enrolled at non-rated providers will occur starting with their renewal that occurs after January 1, 2020.
- Targeted communications with families that remain enrolled at an unrated provider after December 31, 2020, will occur 45-60 days prior to their renewal in 2021.

QR Policy and Operational Changes



Permanent and Temporary Operational Changes

- Permanent
 - Quality Rated will implement a Cohort Group Sign-up System (slots) beginning December 1, 2019.
- Temporary
 - Providers who have a mandatory re-rating (required reassessment) in 2020 will be granted an automatic "hold harmless" year.
 - Voluntary reassessment requests will be suspended in 2020.

Slot-based portfolio submissions, along with the temporary changes, allow better management of the flow of observations

DECAL will create and implement a provisional status.

- Research shows it can take up to a year to become Quality Rated.
- This will allow newly licensed programs to serve families in CAPS immediately.
- This can support current unrated, non-CAPS providers to choose to accept CAPS scholarships.

Provisional Status





DECAL will create and implement a *probationary* status.

- Despite best efforts, some programs complete the rating process and do not score high enough to receive a 1-, 2-, or 3-star rating.
- Some programs may allow their rating to lapse for some reason when it comes time for their 3-year renewal.
- Need a mechanism to ensure continuity of care for children and families.
