Child Care Tuition Assistance Program for Early Educators



New **pilot** program designed to support providers to recruit and retain staff:

- DECAL will provide financial support to offset cost of tuition for staff members' children
- Pilot group will include up to 30 programs
- Application will open in Fall 2023
- Participating programs will be chosen at random and notified via email



Laws Passed to Support Literacy

SB 211 Establish the Georgia Council on Literacy

- Tasked with addressing issues relating to increasing the literacy outcomes of Georgians from birth to adulthood
- Comprised of legislators, educators, literacy advocates, family and community partners

HB 538 Georgia Early Literacy Act

- Aims to improve the quality of early reading instruction
- Will provide for the establishment and implementation of evidencebased literacy instruction and curriculum for students



SB 211: GA Literacy Council

- Establishes the GA Literacy Council
- 30 members include appointments by Governor, Lt. Governor, Speaker including:
 - Literacy and education specialists, local and state board of education members, local superintendents, library representation, legislators and dyslexia specialists are included in appointments
- Council will be attached to Governor's Office of Student Achievement

Responsibilities of the GA Literacy Council

- Make recommendations on new and existing teacher training relating to evidence-based literacy instruction;
- Review community-based literacy programs and make recommendations for improvements;
- Review changes/updates to Quality Basic Education (QBE) formula to enhance literacy instruction;
- Review statewide birth-age 5 initiatives and suggest policy and budget changes;
- Provide a report to Governor, OPB, Speaker and Lt. Governor on the conditions, needs, issues and problems relating to state literacy outcomes; include recommendations for legislation and appropriations to support literacy outcomes (Nov. 30th).

Birth to Five Subcommittee

- Review and discuss current educational and literacy programs implemented in B-5 settings

HB 538 – Georgia Early Literacy Act

Teacher Literacy Training

- <u>Beginning July 1, 2025-</u> DECAL shall require teachers in all programs (licensed or commissioned) to receive training on developmentally appropriate evidence-based literacy instruction.
- By July 1, 2025- All kindergarten through third grade teachers shall complete a training program developed or procured pursuant to this Code section.
- GaDOE shall develop or procure training programs for K-3 teachers on:
 - Science of reading,
 - Structured literacy,
 - Foundational literacy skills, and
 - Universal reading screeners to inform them about student needs

Happy Helpings Events

- Nutrition Services Division partnered with Happy Helpings sponsors to host events promoting the importance of combining good nutrition with physical activity.
- Events held in June with Rabun County Family Connection and Bryan County Board of Commissioners to officially kick-off the summer meals season.
- Spike event held in July with Bread of Life
 Development Ministries to remind families that summer
 meals are available until school starts.
- Along with multiple physical activities that included bean bags, hula hoops, jump ropes and hopscotch, children enjoyed a nutritious meal, stay hydrated with a hydration station that included fruit and herb infused water, and taste-tested Georgia grown fruits and vegetables. Nutrition education materials were also provided.









Farm to School Grant

- USDA awards competitive Farm to School grants that support planning, developing, and implementing farm to school programs.
- Nutrition Services was awarded \$154,872 from USDA plus a state match of \$51,624 (\$206,496 total) to implement four initiatives:
 - Implement a two-year long Farm to ECE Procurement Grant program to support select CACFP sites and farmers in local procurement through workshops, technical assistance, grant funds, certifications, and mentorship;
 - 2. Co-host the 9th Farm to School and ECE Summit alongside Georgia Organics at three different locations across the state;
 - 3. Partner with the Black Child Development Institute to create an Early Childhood Wellness Toolkit with developmentally appropriate and culturally responsive activities connected to Nutrition, Physical Activity, and Farm to ECE; and
 - 4. Partner with Small Bites Adventure Club to provide high-quality, monthly turn-key food education resources and recipes, family engagement programming, and professional development for ECE educators.




SEEDS for Success Helpline

 - Strengthened collaboration with other DECAL divisions and partner agencies






Helpline requests increased 33% from School Year 2022 to School Year 2023







Most Helpline requests were from early childhood providers, followed by families






Most Helpline requests were related to challenging behavior






Helpline calls for infants and toddlers more than doubled from School Year 2022 to 2023

Pyramid Model Training Series

- The <u>Pyramid Model</u> is a framework of evidencebased practices for promoting young children's healthy social and emotional development
- DECAL is utilizing federal recovery funds to provide Pyramid Model training to the early learning workforce
 - Directors/ Administrators/ Principals
 - Infant, Toddler, Preschool & Pre-K teachers
- Training includes online e-modules and professional learning community sessions






Pyramid Model Training Series

- Child Trends is conducting an evaluation of the training series




Pyramid Model Training Series: Year 1 Pilot

Economic Impact Study

- Follows earlier studies from 2008 and 2016
 - Will be divided into multiple phases to help understand the impact of COVID-19 and COVID-19 relief funds
- Report 1 will be released by September 30, 2023
 - Uses 2019 as a baseline
 - Compares gross receipts between 2019 and 2020; more detailed impact analyses in later reports
 - Includes a chapter detailing DECAL's 2020 pandemic response






Change in Gross Receipts

COVID-19 Impact

"The pandemic had a sharp and lingering impact on employment and wages during 2020. While employment followed the same pattern as enrollment, dropping dramatically in late March of 2020 and slowly improving, it never fully recovered. For instance, by December 2020, employment was still down approximately 18% from pre-pandemic levels and had still not fully recovered by the end of 2021 (which will be explored further in future phases of this research). Wages were also lower, down \$3,200 annually on average from 2019 to 2020."

"DECAL's efforts during the first nine months of the pandemic to support the industry were instrumental in keeping businesses afloat and providing resources to families and providers."



School-Age Grants 2023

- Any provider that currently served school-age children or had served school-age children within the past year was eligible to spend awarded amounts on school-age specific materials.
- Launched February 6th, 2023 until June 30th, 2023
- Funded through the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA).

- ClassWallet is an online digital wallet
- Provided a tool that allowed DECAL to give access to selected programs to make "rule-based" purchases
- Awarded funds to providers as directed by DECAL
- Monitored orders to ensure appropriate items were purchased
- Generated reports on spending

School-Age Grants Rule Based Purchases



Previous data from providers: Most needed items for School-Age Programs











Child Care Services Proposed Rule Revisions October 1, 2023



Rules and Regulations for Child Care Learning Centers 591-1-1-

.07(2) Immediately notify Parent(s) and obtain specific instructions until child can be picked up or returned to group.

When professional medical attention is required, or

When child experiences symptoms of moderate discomfort such as elevated temperature, vomiting or diarrhea.

<u>or</u>

When child is involved in an incident that puts their health and/or safety at risk (e.g., missing from program, left on vehicle, escaped from building/playground, etc.)

DECAL proposes to amend this rule chapter to increase health and safety awareness for parents that have children in care and require programs to immediately notify parents in the event that a child is involved in an incident that puts their health and/or safety at risk. This could include situations such as, but not limited to, the child becomes missing from the program, the child escapes the building or playground, the child is left on a vehicle, etc.



Rules and Regulations for Child Care Learning Centers 591-1-1-

.16(g) False or Misleading Information. The application for a License or Permit, including the Records Check Application, must be truthfully and fully completed. In the event that the Department has reason to believe that the application has not been completed truthfully, it may require additional verification of the facts alleged. The Department may refuse to issue or revoke a License or Permit where false statements have been made in connection with the application or any other documents required by submitted to the Department..

DECAL proposes to amend this rule chapter to add language to more accurately align with language in O.C.G.A. § 20-1A-1et seq that would allow the Department to revoke a program's license in the event that false or misleading information is submitted.





Rules and Regulations for Child Care Learning Centers 591-1-1-

.36(7)(c)3. The driver or other designated Staff person shall also document in writing the <u>dates and the</u> departure/arrival times for all types of transportation on the passenger transportation checklist as follows: School Transportation each time the vehicle departs from the Center, is loaded or unloaded at each school and when the vehicle returns to the Center. Home Transportation - each time the vehicle departs from the Center, arrives at the location where any child is picked up or dropped off and when the vehicle returns to the Center. Field Trip Transportation- each time the vehicle leaves the Center, arrives at a field trip destination, leaves a field trip destination, and returns to the Center.

DECAL proposes to amend this rule chapter to clarify requirements to help providers understand what is needed to meet the intent of the rule and add language that requires the documentation of the dates transportation is conducted by or on behalf of the program.



Rules and Regulations for Family Child Care Learning Homes 290-2-3-

.11(1)(b) Parents of any Child who becomes ill or is injured while in care shall be notified immediately of any illness or injury requiring professional medical attention, or any illness which may not require professional medical attention but which produces symptoms causing moderate discomfort to the Child, such as, but not limited to, any of the following: elevated temperature, vomiting or diarrhea.

<u>Parental Notification. Parents must be notified of incidents, illnesses, or injuries as follows:</u>

Notification

Immediately notify Parent(s) and obtain specific instructions until child can be picked up or returned to group.

Notify Parent(s) by the end of the day.

When

When professional medical attention is required, or
When child experiences symptoms of moderate discomfort such as elevated temperature, vomiting or diarrhea, or

When child is involved in an incident that puts their health and/or safety at risk (e.g., missing from program, left on vehicle, escaped from building/playground, etc.)

When professional medical attention is not required, or
When child experiences symptoms of less than moderate discomfort, or
When child experiences an adverse reaction to prescribed medication which does not

constitute moderate discomfort.

DECAL proposes to amend this rule chapter to align with wording to match Child Care Learning Centers and to increase health and safety awareness for parents that have children in care and require programs to immediately notify parents in the event that a child is involved in an incident that puts their health and/or safety at risk. This could include situations such as, but not limited to, the child becomes missing from the program, the child escapes the building or playground, the child is left on a vehicle, etc.
