## • Annual Requirements Reminder and Updated Documents Charts •



The 2016 CACFP Annual Training and Annual Certification Requirements have been made available and should now be completed. If you have not yet completed annual renewal, please do so as soon as possible. Once annual training and certification requirements have been satisfied, the 2016 approved CACFP application is available to complete in CNP 2000.

Without completion of the annual training, assessment questions, and certification requirements, institutions will not have access to the 2016 CACFP application and will not be able to file 2016 claims for reimbursement. Institutions that do not complete FY 2016 CACFP annual training and requirements by April 30, 2016 must reapply to participate in the CACFP as a new institution.
