Happy Helpings, Georgia's Summer Food Service Program, provides free nutritious meals for all children during the summer.

Organizations needed statewide to host meal sites for Happy Helpings, Georgia's Summer Food Service Program.

Atlanta, Ga., (June 1, 2022) – During the summer months when school is out, many children no longer have consistent access to nutritious meals and snacks. Happy Helpings, Georgia's Summer Food Service Program, helps to fill the hunger gap by providing free, nutritious meals to any child 18 years old and younger. Adults 19 years and older who are enrolled in school programs for persons with disabilities may also receive meals.

Families can locate a Happy Helpings meal site in their area by texting "Summer Meals" to 914-342-7744 or calling the Hunger Hotline at 1-866-348-6479 (English) 1-877-842-6273 (Spanish).

In an effort to expand access to these meals, the Georgia Department of Early Care and Learning (DECAL) is looking for organizations to host local meal sites this summer. Organizations that agree to host meal sites will work with approved Happy Helpings sponsors, and the sponsors will provide fresh, well-balanced meals for each site.

"Happy Helpings plays a vital role in providing children with the healthy meals they need every day," said Tamika Boone, director of Nutrition Services for DECAL. "Hosting a Happy Helpings site in your local community ensures that meals and snacks reach the most vulnerable children throughout the state," she added.

Meal sites may be located where children congregate such as parks, churches, schools, libraries and apartment complexes. Meals must be served in low-income communities where at least 50 percent of children are eligible for free and reduced-price school meals or in other locations where at least 50 percent of the children enrolled in a specific program are eligible for free and reduced-price school meals.
