Nutrition Services has released new policy guidance for all SFSP sponsors. Below is a list of the guidance:

- **DECAL Policy No. SFSP17-20**: This policy was revised from its previous version. Revisions include further guidance in the following sections:
 - a) Common Financial Recordkeeping Requirements (page 2)
 - b) Financial Management and the CACFP/SFSP Budget (page 5)
 - c) Separations of Costs Records per Program for Multi-Program Organizations (pages 5 & 6)
 - d) Use of a Separate Program Account vs. a Commingle Account (page 6)

The guidance serves as an addendum to the current CACFP and SFSP recordkeeping policies and addresses common problematic areas of program financial recordkeeping among SFSP organizations. Included in this guidance is a Financial Recordkeeping Checklist.

• New Web-Based Interactive Food Buying Guide Now Available! •



The Nutrition, Education, Training, and Technical Assistance (NETTA) Division of the Food and Nutrition Services Child Nutrition Program Unit has released the first phase of the new web-based, interactive **Food Buying Guide** (FBG).

The features associated with this resource include search and navigation features, comparison features for yield information, and the ability for users to create and save favorite food lists. The tool also incorporates an exciting new feature: the Interactive Product Formulation Statement Workbook. This feature allows manufacturers to easily search and populate selected food items, calculate their product's contribution statement, and generate a document that provides crediting information for CN Program Operators.

• Requirements for Participation in the Non-Congregate Demonstration Project •

As a refresher, a sponsor must meet several requirements to participate in the Non-Congregate Demonstration Project. Under the demonstration project, SFSP sponsors operating approved outdoor meal sites without temperature-controlled alternative sites may operate as non-congregate sites on days when the area is experiencing excessive heat.

Non-congregate meal service shall be permitted only on days when the National Weather Service (NWS) has issued a Heat Advisory, an Excessive Heat Warning, or an Excessive Heat Watch for the area that has been approved for an outdoor meal site.

For summer 2017, interested sponsors must notify DECAL of their intent to participate in the demonstration project and must identify outdoor congregate meal sites lacking temperature-controlled alternative sites that would be included in the demonstration project before initiating their summer program.
