New SFSP Policy Guidance and Memoranda



Nutrition Services released new policy guidance for SFSP sponsors. The new guidance is below:

- Standards for Development of Procurement Policy Consistent with CACFP and SFSP Federal Requirements (Revised): This memorandum provides general guidance on procurement standards for the CACFP and SFSP. A few revisions were made since this guidance was issued October 1, 2015. Revisions are highlighted in yellow throughout the document.
- Excess Funds in the CACFP and SFSP: This memorandum provides additional guidance on the use of excess funds for institutions operating both the CACFP and the SFSP. This guidance replaces DECAL policy memorandum, Excess Funds in the CACFP and SFSP, December 1, 2015.
