Greetings CACFP Sponsors and Institutions,

As monitoring is an essential part of CACFP oversight and ensuring Program integrity, the Child Nutrition Program Integrity Final Rule instituted new State agency monitoring requirements. These new requirements include:

- A 2-year compliance review for institutions that conduct activities other than those related to the CACFP, institutions that had prior reviews that detected serious management problems, and institutions that are at risk of serious management problems.
- An annual review of one month's bank activity for all sponsoring organizations.
- An annual administrative cost review for sponsoring organizations of unaffiliated centers.

On September 18, 2024, Nutrition Services issued **CACFP Policy 41 – State Agency Monitoring Requirements in the Child and Adult Care Food Program**. This new policy incorporates prior monitoring requirements still in place and new changes resulting from the final rule.
