Dear Child Care Providers,

Happy spring! I hope you're enjoying this brief time of Georgia weather between too cold and too hot (it won't last long)!

I want to remind of a couple of things that were sent to you recently via email.

First, you are now eligible to receive funding to purchase

COVID-19 at-home self-test kits and personal protection equipment (PPE). The amount of funding you receive will be based on the type of program you operate (CCLC or FCCLH) and your enrollment. These funds, made possible by DECAL, come from the American Rescue Plan Act. You do not have to apply for

these funds. The funds can be accessed and must be spent through a vendor called ClassWallet. You should have received an email from ClassWallet (info@classwallet.com) that included directions for accessing the funds. If you did not receive an email from ClassWallet by April 4, 2022, please check your spam and clutter folders. If after checking all your folders you did not receive an email from ClassWallet, contact help@classwallet.com or 877-969-5536.

I also want to remind you that beginning April 1, 2022, DECAL Child Care Consultants began resuming more than one in-person child care visit per day. As you remember, up until this time our COVID precautions included only visiting one child care program each day. With the decline of COVID cases throughout the state, we are making progress toward normal operations. The health and safety of you, your staff, the children you care for as well as the DECAL staff are our highest priorities. If there are changes in the status of COVID cases in Georgia, we will modify our practices.

Clean Water for Georgia's Kids

Childhood exposure to lead can cause lifelong and irreversible mental and behavioral defects. The Department of Early Care and Learning (DECAL) is joining the Georgia Department of Education and the nonprofit research institute RTI International to help schools and child care programs test,



communicate, and remove lead from their drinking and cooking water. Thanks to a federal grant these tests are free of charge and are a great safeguard for children and their families.

- 1. Once registered for an OLLI training, log into the Georgia Professional Development System (GaPDS).

- 3. Then, find the OLLI training you wish to begin.
- 4. Click "Attend Training" and your training will begin in a new window.
