Dear Child Care Provider,

I hope your summer is going well and that you're finding opportunities to stay cool! Child Care Services implemented new rules on July 1, 2025. To access information on the new rules, please go to Rules and Regulations. If you have questions about the new rules, please contact you Child Care Consultant.

I want to take a moment to focus on two of these rules. There were two choking deaths in Georgia child care in 2024. We want to do everything we can to prevent another choking death in licensed child care. Previously, child care staff had to be pediatric CPR/pediatric First Aid certified within 90 days of employment. The new rule shortens the timeframe to 45 days. The second rule requires a teacher who is pediatric CPR/pediatric First Aid certified be present in any open classroom whenever children are present.

We cannot stress enough how quickly choking can happen and how important it is that someone who knows what to do is there with children. We also know that changing rules isn't enough. Over the next several months, DECAL is launching a choking prevention campaign to support child care staff in safe feeding practices. There will be training opportunities as well as educational materials to reinforce best practices in serving food for teachers and cooks.

# Beat the Heat: Indoor and Outdoor Activities in the Summer



Summer is here, and it's the perfect time to get kids moving! Children need at least one hour of physical activity each day—but it doesn't have to feel like exercise. Games, dancing, and playing all count!

Outdoor play is great for development, but rising temps can be risky. Young children are especially vulnerable to heatrelated illnesses like dehydration and heat exhaustion.

#### **Tips for Safe Summer Play:**

- Head outside early, before it gets too hot! It's okay to edit classroom schedules around weather conditions.
- Utilize playground shade structures. Also, use shade from tents, trees, and umbrellas.
- Offer of plenty of water for drinking.

Here are some fun physical activity ideas for small spaces, both indoors and outdoors, to keep children active. Be sure to click on the linked headings for additional information:

#### **Indoor Activities:**


- 1. <u>Dance Party:</u> Turn on some kid-friendly music and have a dance-off. It's a great way to get moving and have fun.
- 2. <u>Obstacle Course</u>: Use pillows, chairs, and toys to create an indoor obstacle course.
- 3. <u>Yoga and Stretching:</u> Follow along with a kid-friendly yoga video or do some simple stretches.
- 4. **Simon Says:** Play a game of Simon Says with active commands like jumping jacks, running in place, or hopping on one foot.
- Scavenger Hunt: Create a list of items for kids to find around the classroom. Add physical challenges like "hop to the rug" or "tip toe to the cubbies."

#### **Outdoor Activities** (in shaded or cooler areas):

- 1. <u>Water Play:</u> Set up a small splash pad, sprinkler, or water table for some cool water fun. Ensure staff are within arm's length of children during all water play to provide constant supervision.
- 2. **Treasure Hunt**: Hide treasures around the play area and create clues for the children to find them. For example, "Look under the big tree" or "Find the red flower." This activity promotes problem-solving and exploration.
- Sidewalk Chalk Games: Draw hopscotch or mazes for active play.
- 4. <u>Garden Planting:</u> Gather small pots, soil, seeds, and water. Under constant supervision, let the children plant seeds in small pots and water them. This helps kids hone their fine motor skills and learn about plant growth.

#### **Tips for Staying Cool:**

- <u>Hydration</u>: Make sure kids drink plenty of water before, during, and after activities.
- Cool Clothing: Dress children in light, breathable clothing.
- Shade: Utilize playground shade structures. Also, use umbrellas,



• Timing: Schedule outdoor activities for early morning or late afternoon when it's cooler.


#### **Physical Activity Resource:**

No matter the weather, children can stay active—even in small spaces. Always adhere to CCS's Rules and Regulations regarding weather conditions affecting outdoor play. If temperatures get too high, bring children indoors for physical activity. Keep children safe, hydrated, and



healthy by staying alert and prepared. Have fun, stay cool, and enjoy a
