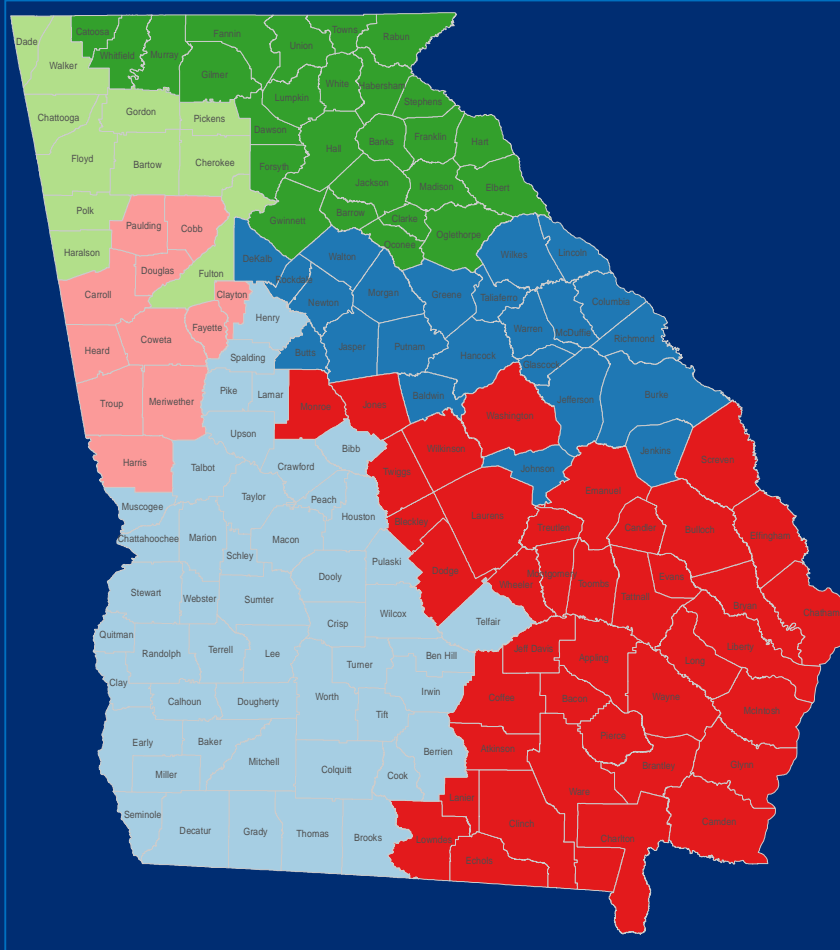

Funding for Community Transformation Grants

- DECAL received Covid-19 Relief funding through the federal American Rescue Plan (ARP) Act.
- To support child care providers, families with young children, and the state's early care and education (ECE) workforce.
- Resources to support the state's ECE infrastructure, raising child care quality, and increasing access to care.



Purposes of the Community Transformation Grants

- Provide community-level supports for Georgia's children birth to eight and their families.
- Increase opportunities for sustainable community collaboration.
- Create new opportunities for communities to innovate at the local level to address critical needs.
- Support additional research and evaluation for how these grants can provide measurable and hard to measure impacts.
- Develop “blueprints” for activities that can be expanded or taken to scale.



Timeline

- **September 1, 2022-** Application released
- **September 30, 2022:** Application due
- **November 16, 2022:** Grantees notified
- **January 1, 2023:** Grants begin
- **June 30, 2024:** Grants conclude



Community Transformation Grants: The Basics

*This grant is designed to support communities in creating projects that will **address local needs related to their B-8 population.***

- Communities may receive up to **\$125,000** to design and implement their project.
- Grant duration is 18 months: January 1, 2023, to June 30, 2024.
- Communities will select 1 of 10 focus needs to address with their proposed project.
 - The focus needs align with Georgia's Preschool Development Grant Birth through Five (PDG B-5) Needs Assessment findings ([view the report here](#)) and with recommendations from the Urban Institute's stakeholder engagement work with Georgia ([view the report here](#)).



Focus Needs

**Where not specified, please consider the target age range of children to be birth through eight years old.*

- 1) Increasing access to high-quality early childhood programs for infants and toddlers (6 weeks to 36 months).
- 2) Increasing access to high-quality early childhood programs for dual language learners.
- 3) Increasing access to high-quality early childhood programs for children living in rural areas of Georgia.
- 4) Supporting children with social-emotional and behavioral needs.
- 5) Reducing food insecurity for children and their families.



Focus Needs

- 6) Strengthening and coordinating early learning services for children in foster care or protective services to ensure they have needed supports and resources.
- 7) Providing mental health services for children and their parents and caregivers.
- 8) Providing enhanced services to young children related to the early identification and treatment of developmental delays and disabilities.
- 9) Developing a system of care to support children and their families experiencing homelessness.
- 10) Supporting the ECE workforce (including early childhood teachers, program directors and administrators, family child care providers, and other ECE professionals working directly with children and families in ECE programs).



2021-2022 Community Transformation Grants

- In 2019, Georgia was awarded an \$11.2 million Preschool Development Grant Birth through Five (PDG B-5) Renewal Grant.
- DECAL awarded Community Transformation Grants to 8 Community Collaboratives.

Introduction

Through the federal American Rescue Plan (ARP) Act, the Georgia Department of Early Care and Learning (DECAL) has received COVID-19 relief funding that can be used to support child care providers, families with young children, and the state's early care and education (ECE) workforce while also adding resources to support the state's ECE infrastructure, raising child care quality, and increasing access to care.

As part of Georgia's plan to use ARP funds to support providers, families, and the ECE workforce, DECAL is issuing Community Transformation Grants to support projects that increase access to early childhood services and resources. This grant program envisions the creation of early education partnerships composed of community agencies and other stakeholders that will design, tailor, and implement innovative projects that address critical local needs. It is hoped that many of the projects funded through these grants
