What is important to you and your family when choosing child care: Cost? Hours? Quality of care? Size of the program? This checklist identifies important aspects about a program to consider and questions to ask when visiting a potential child care program. Identify the questions on the checklist that are most important to you, and ask them during your visit to a program.

Child Care Programs to Consider

Why choose a licensed child care program?

Licensed child care facilities follow state licensing rules to ensure children are in a safe and healthy environment. Licensed child care programs in Georgia:

- Receive a minimum of two unannounced inspections from the state of Georgia to ensure the program is following health and safety guidelines.
- Are required to comply with state health and safety guidelines for child care.
- Have child care program staff who are trained in CPR and First Aid, and have someone on premises with this training whenever children are present.
- All child care program employees in a licensed facility must have a satisfactory criminal background check.
- Routine cleaning and sanitation of indoor and outdoor play areas and equipment.
- Prohibit smoking on premises during hours of operation.
- Teachers and directors must have a minimum of 10 hours of professional child care and child development training a year.

Before you visit a facility, know that there are two types of licensed child care programs in Georgia:

- Family Child Care Learning Home: A Family Child Care Learning Home is operated in a private residential home and provides child care for children less than 18 years of age for less than 24 hours per day. Family Child Care Learning Homes care for three, but no more than six children for a fee.
- Child Care Learning Centers: A program operated by an individual or business that provides group care for pay. These have seven or more children under 18 years of age, for less than 24 hours.
