"We Care, Child Care Sweepstakes" to Award College Scholarships to Four Georgia Children

Sweepstakes Begins July 1

ATLANTA — July 1, 2025 — The Georgia Department of Early Care and Learning (DECAL) and Georgia's Path2College 529 Plan has opened entries for this year's We Care, Child Care Sweepstakes. A total of four Georgia winners — one from each region in North, Southeast, Southwest Georgia, and Metro Atlanta — will be randomly selected to receive a \$1,529 college scholarship. Each winner's child care program will also receive \$1,529 to support early learning efforts. Entries may be submitted through Thursday, July 31, 2025 at path2college529.com/wecare.

The sweepstakes is open to Georgia families with a child (age 13 or younger) who attends a DECAL-licensed child care program. Past winners have included families from more than 30 cities and towns across the state, from Atlanta to Albany, Savannah to Hiawassee. The partnership has awarded more than \$81,000 to 38 future college-bound students and has helped inform families about saving for college through Georgia's Path2College 529 Plan.
