Applications to Provide Georgia's Pre-K Program Now Available

Deadline for Applying is 5 PM on March 28, 2025

ATLANTA, Ga., (March 10, 2025) – The Georgia Department of Early Care and Learning (DECAL) has released the application for new and returning providers of Georgia's Pre-K Program for the 2025-2026 school year. Applications to provide Georgia's Pre-K Program for the next school year must be received by DECAL by 5 PM EDT on **Friday, March 28, 2025**.

Georgia's Pre-K Program is an educational program for age-eligible children in Georgia funded by the Georgia Lottery for Education. The research-based, robust program prepares children for success in Kindergarten and later school years. Applicants for the Pre-K grant must be a licensed child care program, local school system, or a Head Start program. Pre-K programs are offered in a variety of settings: public schools; for profit and nonprofit child care learning centers; military bases, and faith-based organizations.

To attend Georgia's Pre-K in the 2025-2026 school year, a child must be four years old on or before September 1, 2025. Georgia's Pre-K Program normally operates on the public school system calendar for the length of a typical school day. This year, approximately 70,000 four-year-olds are being served in 3,785 Georgia's Pre-K classes at 1,912 locations.

"Since its beginning 33 years ago, Georgia's Pre-K Program has grown and improved to meet the ever-changing needs of Georgia's children and families," said DECAL Commissioner Amy M. Jacobs. "Research supports that, on average, children's skills in language/literacy, math, self-knowledge, and general knowledge gained during their Pre-K year were sustained through Kindergarten. These findings confirm that Pre-K provides a strong foundation for future learning.

Susan Adams, Deputy Commissioner for Pre-K and Instructional Supports, adds, "Georgia's Pre-K Program would not, could not be successful without the providers, teachers, and assistant teachers dedicated to engaging Georgia's four-year-olds every day. We encourage eligible providers to partner with us in fulfilling our mission to enhance the academic and economic future of Georgia's children, families, and communities."
