Self-Assessing Taxes Online



Learn how to evaluate your taxes with the Confidence in Quality Tax Rubric App

Assessing your taxes can feel intimidating, but there are tools available to make the process easier. This online tool, which is geared specifically towards child care businesses, is something that can be completed with confidence and in a short amount of time.

The Confidence in Quality Tax Rubric App was developed to allow child care business owners to evaluate their own federal tax returns for consistency with best practices for their program type. The app provides child care businesses with a personalized review of their potential tax risks and opportunities summarized in a downloadable report that is easy for both you and your tax preparer to understand. This resource will help walk you through the process of using the Confidence in Tax Quality App to simplify your tax preparation this coming tax season.

This tool was developed with the generous funding and support from the Wisconsin Early Childhood Association (WECA) through the Wisconsin Department of Children and Families.



Getting Started

Here's what you will need in order to begin:

- 1. Your Schedule C of your Form 1040 from your latest completed tax return.
- 2. 15 minutes

What is a 1040 Schedule C? Let's take a look at what the Form 1040 Schedule C looks like:

Using the App

Now that you have your Schedule C, you're ready to begin! The app will ask you to accept the user agreement and confirm your type of business before taking you through a series of questions based on your tax form. The entire process can be completed in 5 simple steps.*

Step 1: Visit the Confidence in Quality Tax Rubric App Site

The app can be accessed by clicking the link above or copying and pasting https://civitas-rubric-eng.glideapp.io/dl/d0a5f4?full=t into your laptop, desktop, phone, or tablet browser search bar.

Step 2: Answer the Questions that Appear on Each Page

Proceed through the site's prompts by answering "Yes" or "No" questions. Answers to each question are dependent on if you have information entered in the relevant line.

Examples could include:

Does LINE 1 Gross Receipts include all your revenue earned for the year, such as all parent fees paid, subsidy revenue, Child and Adult Care Food Program (CACFP), cash, checks, and cash app payments?

Step 3: Check for Common Errors

Answer the final general questions to check for common errors.

Step 4: Enter Your Email Address

Insert your email address in the submission box.

Step 5: Hit Submit and Check Your Inbox for Your Report
