Grants Support Partnerships Between Child Care Providers and Elementary Schools

Atlanta, GA. (**April 14, 2025**) - The Georgia Foundation for Early Care + Learning, in collaboration with the Georgia Foundation for Public Education, has selected the grantees of the Early Literacy Alignment Mini Grant (ELA Mini Grant) 2025.

This grant program, which provides up to \$5,000 in funding to each recipient, fosters strategic partnerships between public elementary schools and local child care providers to strengthen early literacy practices.

The ELA Mini Grant supports collaborative efforts to align innovative literacy practices across educational settings. By focusing on professional learning and alignment, the grant promotes smoother transitions for children moving from prekindergarten into kindergarten. This initiative ensures that rising kindergarten students have a more consistent, effective learning experience from the start of their educational journey.

The ELA Mini Grant is funded through the generous contributions to the Georgia Foundation for Early Care + Learning and the Georgia Foundation for Public Education, supported by the PEACH Education Tax Credit program. These funds are critical in enabling innovative collaborations and advancing the literacy development of Georgia's children.
